ADDENDUM A: BACKGROUND INFORMATION TO INFORM PLAN

Strengths

The all student group met interim goal and improvement targets on the 2021-22 PSSA for both Math and ELA.

According to the 2021-22 PVAAS data for ELA and Math, the all student group exceeded the standard demonstrating growth interim goal for both ELA and Math

The Black, Hispanic, White, Economically disadvantaged, English Learner, and Students with disabilities subgroups all met interim goal/improvement targets for both the 2021-22 ELA and Math PSSA s

PBIS process in place which will build relationships between students and teachers

After school is available to all students to enrich their skills in reading and math

The following subgroups for Math exceeded the Statewide standard demonstrating Statewide Average Growth Score (75.3%): Black (81%), Hispanic (91%), White (83%), Economically Disadvantaged (91%), and English Learners

The Lunch and Learn went well. The students ate lunch, listened

Challenges

The Black (18.2%), Hispanic (8.2%), White (22.8%), 2 or more races (17.9%), Economically Disadvantaged (11.9%), English Language (6.7%) and students with disabilities (16%) subgroups did not meet the performance standard measure for regular attendance.

11.1% of all students scored proficient/advanced on the 2021-22 Math PSSA.

31.9% of all students scored proficient/advanced on the 2021-22 ELA PSSA.
