## Coatesville Area Intermediate High School Coatesville Area School District School Parent and Family Engagement Plan

### DESCRIPTION OF HOW SCHOOLS WILL IMPLEMENT REQUIRED SCHOOL PARENTAL INVOLVEMENT POLICY COMPONENTS

- Coatesville Area Intermediate High School will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESEA:
  - *Regularly scheduled meetings are held at the district office with district administrators, principals, reading specialists, community members, and Title I parents.*
  - *Monthly school board meetings are held where the policies are posted (website) for 30-day review.*
  - *Parents will be invited in various activities throughout the year*
- Coatesville Area Intermediate High School will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs.
  - *At Back to School Night, all parents were informed of the Title I policies and the school plan was available to them.*
- The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend.

  - *Listing upcoming meetings on the school's website and monthly newsletter*
  - *Raffles and prizes, related to literacy, for parent/student attendance to reading based school functions*
  - *Meeting times vary*
  - *Provide free babysitting when appropriate*

- Coatesville Area Intermediate High School will use Title I funds to pay reasonable and necessary expenses associated with parent involvement activities:

- Coatesville Area Intermediate High School will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:
  - *Report Cards sent home quarterly*
  - *Provide parents with reading specialist e-mail addresses and phone numbers*
- Coatesville Area Intermediate High School will, at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
  - *Trial implementations of new instructional practices*
  - *Flexible scheduling for meetings based on parent response*
- Coatesville Area Intermediate High School will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
  - *Individual Conferences when requested or needed*
  - *Individual Phone calls when requested or needed*
  - *Reading Specialists provide additional testing data and interpretation of this data when requested or needed on a student*
- Coatesville Area Intermediate High School will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:
  - *A written notice will be sent to parents*

- Coatesville Area Intermediate High School will provide assistance to parents of children served by the school, as appropriate, to better understand state standards and local curriculum:
- *At Back-to-School Night, parents are introduced to the ELA curriculum as well as materials reading specialists and classroom teachers may use for interventions*
- *Curriculum information will be available on the district webpage as well as on the individual school's website*
- Coatesville Area Intermediate High School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
  - *Reading Specialists will provide training for volunteers who will help classrooms with reading and writing support.*
  - *Periodic literacy events are offered to families of Title I students where parents are shown strategies to help improve their child's reading*
- Coatesville Area Intermediate High School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
  - *Meeting for parents and reading specialists to discuss parent involvement plan.*
  - *All students receive a compact that is signed by the building principal, this compact explains the expectations of each stake holder.*
- Coatesville Area Intermediate High School will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

  - *A translator provides immediate Spanish communication during parent meetings*
